Terms and Conditions

All players **MUST** check in prior to commencing play. Annual memberships are not transferable but are REFUNDABLE. Refundable is defined as a prorated amount refunded back to a Member(s) who is unable to continue to play due to a physical condition or health-related matter or due to moving or being transferred out of the area greater than 30 miles from the Club.

An ONGC membership includes applicant, spouse and/or child under the age of 21. You must be at least 16 years of age and have a valid driver's license to rent a golf cart. Applicable cart fees will be charged per membership category.

All annual members accept and guarantee ONGC, that each membership is a contract for all or a portion of the current year of enrollment through December 31, 2016. All Members must comply with the rules and regulations of ONGC and must refrain from crude, rude and inappropriate behavior. Failure to abide by the rules of the Club may result in suspension or termination of membership.

Members who use golf cars owned by ONGC must return the golf car in the same condition as when it was received. Ordinary wear to golf car accepted. The receipt of said golf car in good order and repair is hereby acknowledged by Member. Member agrees to pay or reimburse ONGC for any and all charges arising out of damage to said golf car other than ordinary wear during the term that the Member is operating golf car. Member will be responsible for damages of any kind, whether to person and/or property arising from the use connected with golf car and will hold ONGC and other parties free and harmless from any damages. Member warrants that he/she is familiar with the use and operation of golf car and the rules governing its use and that he/she has the ability to operate and control the same in accordance with such rules. Golf cars are not to be removed from ONGC and are to be returned promptly to the ONGC after use.

ONGC reserves the right to amend, modify or supplement these rules, terms, and conditions at any time and without notice. ONGC reserves the right to close the course due to outings, agronomic practices, special events or inclement weather conditions as it deems necessary. All Members will use the facility at their own risk. Guests are welcome any time at the prevailing daily rate. Rates are subject to change at any time.
